CCH CREDIT APPLICATION

STANDARD TERMS AND CONDITIONS

Customer and Courier Corporation of Hawaii (hereinafter CCH) agree as follows:

1. GENERAL

- A. Customer shall properly mark, securely seal, and properly address, and comply with all laws on all shipments tendered to CCH.
- B. Customer agrees to maintain suitable records for shipments upon which claims for reimbursement for reconstruction expenses in case of loss or damage may be filed. For checks in the process of collection records must set forth the amount of each item, the financial institution and account upon which it is drawn (if any) and the identity of the person presenting the items for deposit, payment or collection.
- C. CCH reserves the right to refuse service to anyone.
- D. **Consent to Search:** CCH reserves the right to search any package at any time.

2. TRANSPORTATION CHARGES

- A. For any services performed, customer agrees to pay CCH pursuant to the rate set forth at the time said services were performed, which are subject to change at any time.
- B. Pay for Courier Corporation of Hawaii's service is due upon receipt of invoice unless otherwise stated.
- C. CCH reserves the right to adjust all tariffs at any time, however, CCH will make its best effort to give 30 days written notification if any changes in fee is anticipated.

3. LIABILITY OF CCH

CCH shall be liable for loss or damage to a shipment, which directly attributable to the negligence of CCH, in the amount of the intrinsic value of the shipment not to exceed \$50.00 per shipment, unless a higher value is declared. Declared value may be stated by the shipper at time of shipment and a fee of \$0.75 per \$100 of insured value. Maximum insurable value is \$5,000.00. At no time will CCH be liable for concealed damage.

4. CLAIMS

- A. Customer shall give notice in writing to CCH of any claim for loss or damage within twenty-four (24) hours after the discovery of any such alleged loss or damage but in no event more than five (5) days after the alleged loss or damage. Unless proper notice shall have been given, all claims shall be deemed to have been waived. No action, suit or other proceeding to recover for any loss or damage shall be instituted or maintained against CCH unless written notice shall have been given to CCH as aforesaid and unless such action, suit or proceeding shall have been commenced within nine (9) months of the day the shipment was tendered to CCH.
- B. Within thirty (30) days after giving written notice of any claim for loss or damage Customer shall furnish CCH detailed written proof of such loss or damage, in a form satisfactory to CCH, which proof of loss or damage shall be substantiated by the books, records and accounts of Customer.
